3. Monitoring of research or animal studies conducted in the animal house
4. Approval of standard operating procedures for the animal house
5. To monitor the working of the animal house as per CPCSEA guidelines
6. To approve the research protocols Part B for submission to IAEC of the college
7. Approval of animal house purchase requirements.
8. To arrange regular IAEC meetings in the college for approval of research protocols.
9. To follow CPCSEA guidelines for maintaining the animal house
10. To purchase new animal from the CPCSEA approved breeding center
11. To prepare and apply standard operating procedures for animal house facility.
12. To monitor use of animals for experimental work.
13. To maintain all records and documents related to animal house facility as per CPCSEA guidelines.
14. To monitor the work of animal house attendant
15. To supervise clean and hygienic conditions in the animal house.
16. To maintain various parameters like temperature, humidity, etc. in the animal house.
17. To supervise regular feeding and watering the animals
18. Take workshop of faculty for how to carry out proper caring and handling of the experimental animals.
19. Any other duties assigned by the higher authority time to time.
