2. To discuss regarding remaining academic calendar schedules for current academic year

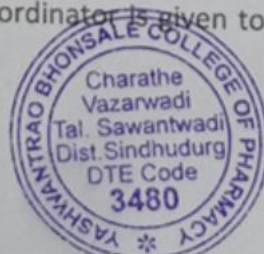


4. To review different points in NAAC SSR
