





- 6) the college shall not admit the students over and above sanctioned intake.
- 7) the college shall appoint the teaching as well as non-teaching faculty as per the University and U.G.C. norms and also provide infrastructure facilities for the purpose
- 8) that the college will apply within one year after completion of five years for NAAC / NBA accreditation and if college not apply for accreditation the affiliation of college will automatically stand cancelled.
- 9) If, it is observed that 50% or less students admitted as per sanctioned intake the action of de-affiliation will be initiated against the college by the University.
